UVL_{RX} Intra-Vascular Light Therapy and Heart Rate Variability

Summary

Stress causes inflammation, which accelerates aging. Stress can both be effectively measured and quantified, using Heart Rate Variability. The results of UVL_{RX} treatment, a unique intra-vascular light therapy, can be measured using heart rate variability, and can be shown to have great therapeutic value.

We are all aware of the deleterious effects of stress. There are many types of stress. Mental Stress occurs in a college freshman taking his first set of final exams. Anger and fear are examples of Emotional Stress. Nutritional Stress occurs when someone eats a food that he/she has a reaction to, such as gluten or dairy. An example of Environmental Stress is exposure to pesticides, when eating GMO food. Being injured in an automobile accident and having surgery are Physical Stressors. And lastly, Infectious Stress occurs as a result of an acute viral or bacterial infection.

In all of the above stressful events, Inflammation is the result. This is mediated through the release of inflammatory cytokines, such as NF Kappa B.

Stress can be effectively measured using Heart Rate Variability. This technology assesses the rhythm by identifying beat to beat variability. As an example, if one has a pulse rate of 60 beats per minute, and each beat is exactly 1 second in length, then there is no heart rate variability, and that person is at great risk for a chronic illness. However, if one beat is 1.00 seconds in length, followed by the next beat at .98 seconds, followed by the next beat at 1.02 seconds in length, then there is excellent heart rate variability, and thus a healthy person.

Heart Rate Variability is used to analyze the health of the Autonomic Nervous System, the automatic, or sub-conscious nervous system, that among other things controls

processes that we don't have to think about, such as your next heart beat, or your next breath. Besides the cardiovascular and respiratory systems, The Autonomic Nervous System (ANS) has effects on the other major systems of the body, such as the Immune System, the Gastro-intestinal System, and the Endocrine System.

Research into HRV has shown that lowered HRV is associated with premature aging, diminished hormone activity, and an increased risk of sudden cardiac death after an acute myocardial infarction. Other research has found that depression, panic disorders and anxiety are also associated with lowered HRV.

The Autonomic Nervous System controls all physiological and metabolic processes within the body. It has two divisions – the sympathetic nervous system and the parasympathetic nervous system. The sympathetic system is your left brained, performance, energy expenditure system, whereas the parasympathetic is your right brained, creative, energy recovery, relaxation system. If this were an athletic event, the sympathetic would be how fast did you run the 100 yard dash, and the parasympathetic would be how long did it take you to get your breath back.

For this test, a sensor is attached to the chest area to record the heart beat for two minutes while the patient is lying down, and for another two minutes when the patient stands. When a patient stands, it is more difficult for the heart to get blood to the head because of gravity, and this represents stress in this test. The results are then graphed, to reveal the activity of the sympathetic and parasympathetic nervous systems, with values ranging between +4 to -4 for each system.

We are all familiar with the negative effects that toxins have upon the body, producing harmful free radicals which have been linked to premature aging and a wide range of disease, including cancer, heart attack and stroke. As a result, anti-oxidant therapies that neutralize free radicals are an important part of all comprehensive health care approaches.

But there is a different type of therapy that is also available. It's called oxidative therapy, and has been shown to be effective in killing bacteria, viruses, and fungus. An example of oxidative therapy is ultraviolet blood irradiation (UBI). Ultraviolet blood irradiation has been used in this country since the early 1900's. *Emmett Knott* pioneered the irradiation of autologous blood on dogs before treating a moribund woman with post-abortion sepsis in 1933 who was thought to be untreatable. With his treatment of blood irradiation, she promptly recovered, resulting in more research and further development of the "Knott" technique.

By the early 1940s, UV blood irradiation was being used in several American hospitals. Into the late 1940s, numerous reports were made about the ability to treat infection, and the complete safety of UV blood irradiation. With the emergence of antibiotic therapy,

the reports suddenly ceased. German research on UVB documents a rise in oxygen consumption and oxidation within the body, as stimulation of mitochondrial oxidation results in greater ATP production.

A new and innovative technology, the UVL_{RX} StationTM from UVL_{RX} Therapeutics, offers a significant improvement in ultraviolet blood irradiation (UBI). Until now, UBI has been administered via an extracorporeal technique, which involves the extraction, irradiation, and return of approximately five percent of a patient's total blood volume. The blood, once drawn, is irradiated with a single wavelength within the ultraviolet light spectrum, and then returned to the patient's body.

The UVL_{RX} StationTM significantly improves upon traditional UBI methods in a number of ways. First, it eliminates the need for blood to be drawn before it can be irradiated with ultraviolet light. Instead, it makes use of a ground-breaking intravenous delivery system that delivers UV light directly into the patient's vein, without the need for tubes, pumps, or cuvettes (small glass tubes) filled with circulating blood. During treatment patients sit comfortably in a chair while an IV is started. A thin fiber optic cable is attached to a small, plastic hub, called a Dry Light AdapterTM (DLATM) that integrates an IV saline drip with a fiber optic delivery mechanism.

The biggest advantages of the UVL_{RX} Station, however, go far beyond the ease and convenience it provides compared to other UBI methods. During treatment, 100 percent of a patients' total blood volume receives light therapy, in contrast to the 5 percent total blood volume that is treated using traditional UBI. Additionally, the UVL_{RX} StationTM delivers three specific wavelengths of light tailored to achieve desired clinical effects. During the first 30 minutes the patient receives UV-A (365 nm) and red light (635 nm). During the next 30 minutes the patient receives red light and green light (535 nm).

Use of these different wavelengths improves and expands the therapeutic potential of the UVL_{RX} Station. Each wavelength targets naturally-occurring photoreceptors in cells. When stimulated with light, the photoreceptors activate key biochemical pathways, generating the therapeutic effect. UV-A inactivates pathogens, the red light stimulates the immune system, and the green light improves the microcirculation.

I conducted a study to objectively evaluate the effects of UVL_{RX}. Seven patients were selected. Initially, a heart rate variability test was performed, followed by the 1 hour UVL_{RX} treatment, which was immediately followed by a 2nd heart rate variability test.

The results in all seven patients showed the following;

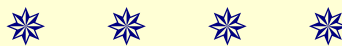
1. An improvement in parasympathetic tone
2. A reduction in sympathetic tone
3. A marked reduction in stress levels as measured by the tension index (TI)
4. An increase in myocardial cell energy production (a lowered ChMR)

Conclusion:

Intravenous light therapy via the UVL_{RX} system has a remarkable beneficial effect on the health of the autonomic nervous system, and can be of great value in optimizing health.

Training and educational materials on all currently recommended instrumentation are available through OIRF.

As a non-profit research organization, we are here to educate and inform our "members" / supporters, and to make instrumentation recommendations based on our years of research. Then, as a fund raising activity, we can assist you with a purchase that will work best in your practice for the most reasonable price.

From our Mission Statement:

"Biological Medicine" – a phrase coined by Occidental Institute during the early 1980's – was intended to be a general and inclusive term that incorporated many non-allopathic or natural diagnostic and therapeutic methods. There is no single product, personality, method or approach within Biological Medicine that will allow you to help all of your patients, with all of their health challenges, all of the time. It is for this reason that we see a constantly changing and developing range of methods coming available to practitioners worldwide.

Some Comments and a Dilemma Regarding UVL_{RX}

The UVL_{RX} device comes highly recommended by two of our honored OIRF Advisors. As you can see from the preceding article **Dr. Michael Galitzer** has extensive experience with this device and has lectured on its effectiveness and application. Additionally **Dr. Simon Yu** is successfully working with two of them in his practice! Other OIRF directors and advisors have investigated purchase and application within their practices.

In the nearly two years that OIRF has been aware of the UVL_{RX} instrumentation, we have attempted to work out a cooperation with this company and have even recommended them to some of our German suppliers/colleagues as they sought to expand their international market into Germany and Europe. However, I must admit that after all this time I have recognized a sort of challenge to our own OIRF policy – almost an ethical issue for me personally – in regard to granting the coveted OIRF recommendation for this device.

As you can see in the quotes on the previous page from our “Instrumentation Policy” statement and also from our “Mission Statement”, OIRF is tied financially not just to the sale of educational materials and programs, but also to the sale of instrumentation. We are a privately and independently funded non-profit organization. That means there is no government or medical/pharmaceutical funding to support OIRF or our work and research in this field which **we** named Biological Medicine – and thus no interference or influence from them either.

Always in the past our OIRF recommendations were based on a series of criteria, questions and standards:

- Thorough testing and practical application to determine efficacy
 - Dr. Sturm had a virtual museum of equipment and “toys” attesting to the vast amounts of invested funding and his hours of research and testing – today we have an elite Board of Directors and Advisors who fulfill much of that task and consideration. With so many devices out there that are simply “bells and whistles and flashing lights” how do you as a practitioner determine what works and what doesn’t? So we need answers to questions like:
 - Does it work?
 - Does the device actually do what is claimed for it?
 - What is the premise or concept of the method?
 - Does the technology actually do the job? (Like for example the filter mechanism of the MORA devices – and yes, the filter really does works!)
- Quality
 - Consider the OIRF recommendations of MORA/Med-Tronik where we have devices that are still in successful and effective everyday practice that were manufactured more than 30 years ago! (Most people’s car cannot boast that kind of quality.)
 - Is there another similar device available that will do the job better?
 - Has the device met any existing standards of the method (i.e. for EAV devices has it met the electrical/technical standards to produce comparable, accurate and reliable readings?)

- Pricing
 - Is the pricing for the device fair?
 - Is there another similar device available at a better price?
 - Is OIRF able to arrange discounts or benefits for purchase by our members?
 - Is the price appropriate for the technology, research and development?
 - Is there a reasonable (or an excessive) “profit” and marketing budget built into the purchase price?
- Availability
 - Where is the device manufactured?
 - Can the device be imported into the USA and/or Canada easily?
 - Is leasing or credit card payment available?
 - Does the manufacturer have product available for prompt delivery?
- Service
 - Does the manufacturer have a proper warranty and repair policy?
 - Does the manufacturer have full repair and service facilities and staff?
 - Is pricing of repairs and service reasonable?
 - Are repairs and service available within reasonable time frames?
- Support
 - Is training available?
 - Are there sufficient operating and training manuals available?
 - Does the manufacturer offer standard or extended warranties?

And of course recently we have had to add:

- Registration
 - Is the device already registered with Health Canada? The US FDA?
 - And more likely, can the device be registered with HC and FDA?
 - Does the device meet all the ISO and certification standards of the country of origin?

And with the development of legitimate, new and effective devices from many other countries (including the USA, Canada, Australia, Austria and so many others):

- Country of Origin or Manufacture
 - Where was the initial research or method developed?
 - Does the method have roots or application in other countries or development?
- Method of development
 - Is this device new research and development?
 - Is this research based on other existing devices or methods?
 - What is the primary premise or concept of the method?
 - Is this device a copy of existing legitimate devices?

And so on and so on . . . I have been involved with the field of Biological Medicine since 1970 even before OIRF first opened its doors as an acupuncture “school”, and I must admit that at times I feel like I have seen it all! But at the very least I have a really good overview and experience of what’s available now and what is being developed. When juggling all of those factors mentioned above along with so many others, the decision to grant the OIRF recommendation for a device or method is never just a straightforward choice of whether or not OIRF will be paid a commission on sales.

Granted, the income received from the sale of our recommended instrumentation is our primary source of funding. In spite of that, we have always maintained a strict policy of neutrality in determining which device will receive that recommendation over or instead of another device. Our longstanding and highly respected reputation has been built on that policy.

One of the primary examples of that is the longstanding loyalty of OIRF to Med-Tronik and MORA over the many “knock off” devices like BICOM, Holimed, IMEDIS, BLOKAT and so on. Each and all of those companies were more than willing to work with OIRF and offer us an appropriate (or sometimes even better) commission structure on sales. But, for us the determining factor was never the money and thus we have stayed true to our non-profit and research corporate status and reputation.

And this is where my “ethical” dilemma arose in terms of the UVL_{RX} Company.

Pros: This is a great device even though developed and made in the USA rather than our usual German recommendations. It comes highly recommended by at least two of our trusted Advisors for effectiveness and ease of application. UVL_{RX} is again a light therapy and we know from BioPhoton (light) Therapy and Color Therapy (standard and also According to Gruba) that the application of such methods is highly effective. They have completed several excellent studies on effectiveness and are now fully registered with the US FDA. Used in conjunction with other OIRF recommended methods such as BioPhotons, Color, MORA Beauty (specialized stress programs) and Ionized Oxygen which are all known to rapidly affect stress and resulting inflammation, we can readily see positive practice application.

Cons: On the other hand the device is somewhat expensive [similar in price to a loaded MORA Nova without the versatility]. But this too is understandable in view of the company’s investments into funding, research, development, FDA registration and now some impressive commercial marketing. So far we have been unable to directly determine quality, service and support issues, although neither of our advisors have reported any negative incidents to us.

And this is where my dilemma arises on a personal level. UVL_{RX} has understandably launched a large international marketing program for this device. Although we have never asked them for a sales commission or referral fee, in recent communications the UVL_{RX} Company has offered to sponsor one or two issues of “The Bridge” newsletter in return for our recommendation and promotion of this product. In many ways this is a very fair and generous offer, and we are grateful to them for this indication of support and respect.

However compared to their huge international marketing plans, our “little” organization can only offer them a limited number of quality sales rather than any kind of promised volume. I like and could easily recommend UVL_{RX}, but in the end it simply and very sadly has come down to the dollars. Promotion and marketing of this product to meet their needs would have to be done in a commercial and somewhat aggressive manner. Although two OIRF Advisors are working with this device, we are unable to offer educational support or purchase assistance which at this time is all done through UVL_{RX} and sales reps.

In comparison with our MORA devices, we can offer you full support and assistance from placement of order through application in your practice. In terms of the commercial aspects, even our Med-Tronik devices (once registered with Health Canada) will become a commercial product and all sales and marketing will have to be spun off into our sister (profit) corporation Praxis2Practice Therapeutic Systems.

And so, I have included the preceding article by Dr. Galitzer in our newsletter as a part of our ongoing research and publication of important quality information and innovation. If you are in a position as a practitioner to do injections (or have appropriate staff), if you are interested in (or are already using) UBI, and if you can see an application for this method in your practice then **UVL_{RX} is an excellent answer**. Should you decide to place an order please let UVL_{RX} know that you heard about them from OIRF. Their contact information is provided on Page 6 following Dr. Galitzer's article.

At this time however OIRF will not be extending our full device recommendation for UVL_{RX} nor will we be accepting any commissions, fees or other financial support. Dr. Galitzer also receives no remuneration from UVL_{RX}. As in all things related to technology, the field of Biological Medicine is expanding exponentially and in many ways it is as yet essentially unregulated in regard to claims, efficacy, technical reliability and methodology. In this and all practice device purchases, do your homework (or ask Carolyn), always be discerning modern consumers and remember that it is our patients who are the ultimate "end-users" of these methods.

Bioresonance & Co. Revolutionize Medicine

Bioenergetic Test and Therapy Procedures Are on the Advance

Today through the newest discoveries in Quantum Physics we experience a reunification of that which seemed separated for centuries: body and spirit. In the meantime the energy field of the human is no longer myth. Methods like Bioresonance encourage this enormously. New devices [*developed*] by space research [*scientists*] revolutionize current medicine. An exciting time comes to us in which it is possible to recognize and treat illnesses before they can manifest themselves. Also for school [*orthodox*] medicine it is a time to not be restricted in one's thinking and to integrate the research results into practice.

“The world which we have created is the product of our thinking. It cannot be changed without changing our thinking.” (Albert Einstein)

Historical

In the Middle Ages the high dignitaries of the Church determined the scientific research so that it was forbidden for example to dissect a human body because of religious taboos. Therefore the practice of medicine was based on vague supposition and interpretations of documents which scholars of antiquity had written.

Only with *Rene Descartes* (1596-1650) they succeeded in freeing medicine from the church restrictions and consequently started the separation of spirit and body. The body was henceforth released for medical research while the humanities remained within the hands of the Church.

Over the centuries the insides of the human body were investigated into the smallest [*part*]. Today we know how organs and cells function and what influence the genes exert. Additionally we know many microorganisms like viruses and bacteria which can be responsible for various illnesses.

With the investigation of DNA, medicine has advanced into an area in which the concepts of oscillations, energy and information play an increasingly important role. DNA is not only the carrier of genetic information (genetics) but its individual functionality is also imprinted with environmental factors (epigenetics). Today it is further assumed that it also acts as a so called hollow cavity resonator and can therefore store light. The fact that cells emit light has already been proven (F.A. Popp). Another way is the possibility of communicating together across the cells.

The Dual Aspect of Matter

In Quantum Physics you are dealing with the characteristics of subatomic particles (the so called Elementary Particles). The elementary particle of the electromagnetic fields is the Photon (also: light quantum), which moves with the speed of light and can have particle as well as wave character (wave-particle-dualism).

The fact that matter particles can also have such a dual nature and therefore can also be associated with wave characteristics, was described for the first time by the French [*physicist*] **Louis-Victor de Broglie**^(a) (Nobel Prize for Physics in 1929).

“Everything Vibrates”

According to **Albert Einstein** mass and energy are equivalent and therefore everything is energy. Because matter is compressed energy and there is no matter which does not vibrate, every energy also has an oscillation.

The well known remark of Einstein: “Everything vibrates” is generally accepted. The whole universe is an oscillation. Every body, every organ, every cell but also every pathogen and any x-arbitrary substance has quite definite frequencies over a typical spectrum. One also designates this as a characteristic frequency pattern.

If everything “vibrates” then it should also be possible that one oscillation can influence another oscillation.

The many years of research by the Japanese [*physician*] **Dr. Masaru Emoto** can make this clear. With his work it showed that the quality of a water could be changed with music, words and pictures. In this case he established connections to the form of the respective ice crystals. According to his theory a water which had been filled into a container marked with positive messages always forms perfect ice crystals. Water which derived from a bottle with negative messages, assumed imperfect crystal forms.

Now if you consider that the human organism consists of up to 80% water, thus you can also easily imagine that certain frequencies can influence the healthy balance in the body. But how does this work?



What is Resonance?

- According to the [German] *Duden Definitions* [dictionary] resonance (from the Greek *resonantia* = resonance) means “resonates, sounds of a body in the vibration of another body”.^(b)
- Physics and technology designate resonance (from the Latin *resonare* = reverberate) as “resonates amplified, a vibration capable system when it is subject to a chronologically variable effect”.^(c)
- “If we examine matter on its oscillation energy, we will establish that different objects mostly vibrate with different frequency. Some also vibrate with the same or with a similar frequency. We know from the piano: If we strike a note on the piano then all the strings which resonate with the struck note – which recognize the struck note and harmonize with it – are likewise brought into oscillation. The notes may be higher or lower: as long as they are found in resonance, they are brought into oscillation.” (*Pierre Franckh*, [1]).^(d)

What is Bioresonance?

We now know that everything in the universe is vibration capable and consequently in principle can go into resonance. This potential to “resonate” is already created in nature and can therefore also be actively opened up.

Thus the oldest Bioresonance system is the sun. With its radiation energy in the form of warmth, light and color it secures our existence and charges us.

For a long time medicine made use of the fact that the human body produces a current and is also otherwise a completely electrical being. Fine current or micro-current was already employed in therapy for illnesses in 1896. In 1920 *Albert Abrams* developed the **Electronic Reaction of the Abrams Method**. He used direct current and combined it with different current resistance to obtain a physical reaction. Today Radionics is established in natural healing. The concept of Bioresonance was shaped only later. The operating principle is still the current.

Kinesiology is also supported by Bioresonance in that it measures physical reactions about the submitted questions through the indicator muscle test.

The Same with the Same Influence

Bioresonance is then based on the assumption that everything up to the smallest physiological level of oscillation results in therapeutic application so that the cells, the organs, the person are only healthy if all characteristic oscillations are in harmonious balance.

If this is not the case, Bioresonance offers an individual treatment with suitable oscillations for every patient. As a result it can concern patient's own oscillations, electronically generated signals, fine or coarse material oscillations or a combination of these possibilities.

This therapy is directly applied with or without magnetic field support.

The active manner of Bioresonance can be described with two concepts from physics: Inversion and Impulse.

Inversion

The phenomenon of inversion has been known in audio technology for a long time. By inversion of an oscillation (to reverse [*to turn upside down*], to mirror) annoying noises are neutralized. The same happens within the scope of Bioresonance application: Annoying oscillations of environmental toxins, parasites, allergens, etc. can thus be made harmless. The oscillation itself is not "deleted" but it no longer burdens the body.

Impulse

Every movable body can transmit its impulse, possibly with a push process to all or part of another body, or can take this over from other bodies. Also fields can portray impulses through strength effect. On the other hand every oscillation releases an impulse. In Bioresonance we make use of this. The utilized frequency gives an impulse to which the organism can align itself harmoniously.

Examples from the Practice

For many years we have worked with different Bioresonance devices in our group practice. For approximately six years the picture-giving Delta-Scan-System^(e) (Non-Linear System Analysis, NLS) is in use and according to experience shows an outstanding success.

Every cell is surrounded by a field, which is registered with the help of the device and can be displayed. As a result a disturbed field is brought into line with a healthy virtual comparison case. Then both curves should run as synchronized as possible. Divergences give an indication of disharmony and therefore of a disturbance. Every food, medication or bacterium contains an information which can change the oscillation field. The goal of the therapist is to determine the respective disturbance factors, to invert and to harmonize the curves. The detected frequencies can be transferred to the patient with the help of the device. It can also “record” the information onto globuli or liquids which the patient receives. Thus the information is evoked daily and the healing chance is strengthened.

Case 1

Mr. M. came into the practice with strong hay fever. By means of the NLS vegetative stress burdens were ascertained. Also the bowel was noticeable.

A probiotic preparation was prescribed, in addition a hay fever complex was transferred and through stimulation of the adrenal gland the cortisol production was stimulated. Afterwards an additional briefly considered autohaemotherapy was no longer considered necessary. After three weeks the hay fever had disappeared. Mr. M. is now hay fever free for three successive years.

Of course the NLS diagnosis is no substitute for a thorough anamnesis with physical examination. It is however a big help in any case.

Case 2

Mrs. K. (63 years old) consulted us approximately three years ago. She suffered for many years from narcolepsy with extremely strong cataplexies. The trigger for this illness was a traumatic experience approximately nine years ago when her home burned down.

At that time Mrs. K. was treated mostly with school medicine, and is [treated] in such a manner up until today.

At the time of the first consultation in our practice Mrs. K. was completely limited in her life. She suffered approximately four to six total cataplexies with complete loss of consciousness. She fell to the ground several times daily and could not leave the house without accompaniment. In her daily routine she had to include at least four sleep phases in her plan, in order to keep herself somewhat awake for the remaining hours. During the first discussions and examinations she fell asleep in the middle of the sentence.

In the first NLS-Scan a strong parasitic burden of the brain ventricles was found. Over the frequency transfer the parasites were inverted until they were finally no longer shown by the control measurements. The traumatic experience was recognized as a so called "Territorial Loss Conflict", was inverted and therefore resolved. After that the substance "Orexin" was transferred in. At the same time Orexin C30 and C200 were administered in the transfer.

In the meantime the patient no longer suffers cataplexies and allows herself only one small sleep pause between 11 AM and 1 PM. Only in extremely emotional situations she still gets light cataplexies in the mouth area which nevertheless are not recognizable to outsiders. She can again shape her life and also travel again.

Result

With Bioresonance the causes of already manifested illnesses can be ascertained and as a result can be directly repaired. Nevertheless much more interesting is that causal patterns (frequencies) of trouble can already be recognized before the serious consequences involve and settle in the body.

Resonantia = Reverberation

Resonance = Echo, Reverberation, Resonate

Through the law of resonance we understand how everything in the universe communicates with one another through vibrations. All objects and living things in our known world, including all organs and cells of our body, possess a unique oscillation. Some oscillate with the same or similar frequencies.

We know this from playing piano: When we hit a note on the piano, all strings that resonate with the struck note are likewise brought into oscillation. The notes could be higher or deeper: As long as they are found in resonance, they are brought into oscillation.

Much like the other strings of the piano which resonate with the struck note, other people, things, or events cannot refuse to resonate when they find themselves on the same resonance level as us.

(e) The Delta-Scan-Bioresonance System is definitely **not** OIRF approved or recommended instrumentation, and successful application varies markedly between practitioners. This device is a general diagnostic scanning unit (based on readings from headphones) which generates a bell-curve statistical type of "diagnosis analysis" primarily based on a searchable data base when given key information of gender, age and (sometimes) weight. Diagnostics based on point and medication testing techniques for example, are much more reliable, individualized and specific.

The so called Bioresonance therapy aspect uses only inversion and/or amplification. Unlike the MORA devices, there is no filter mechanism for separation of harmonious and disharmonious oscillations. For our purposes, this article presents some interesting definitions and concepts that are readily applicable to – or more likely borrowed from – MORA. The successes shown in the described cases however clearly demonstrate the forgiveness, effectiveness and power of BioResonance Therapy especially when based on questionable or unreliable diagnostic criteria.

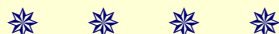

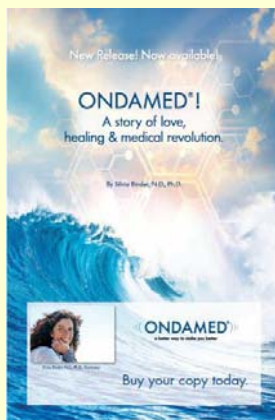
